

#### Q1 Do you support the annexation of Avimor into the City of Eagle?


# Q2 Do you think Avimor should remain under Ada County's control and its possibly more restrictive development standards?

# Q3 How many homes should Avimor be permitted to build, whether under Eagle or Ada County control?




### Q4 Do you believe Eagle residents should have a voice in the Avimor annexation?







### Q5 Should Eagle City Council vote on Avimor's annexation based on Eagle residents' wishes?






