
Q1 Do you think all existing properties should be included in Avimor's annexation application?



Q2 If the first application is approved, what other impacts that might result if excluded property owners don't annex too?



Q3 Do you believe state law should be changed so that existing residents of a city being asked to annex property into their boundaries can vote too?







Q5 Should the City of Eagle create its own public opinion survey about Avimor's annexation?





Q6 Who do you believe will do a better job in managing restricted growth in or near the foothills?












