These Requests should be deemed continuing, and if the Defendant/Counter-Claimant or counsel discover additional information as to the matter inquired of in these Requests between the time the answers are made and the date of the trial, supplemental answers should be made informing the Plaintiff/Third-Party Defendants and counsel as to such newly discovered information prior to trial.

## **INSTRUCTIONS**

- A. When answering these Interrogatories and Requests for Production you are requested to furnish all information available to you, including information in the possession of your attorneys, investigators, employees, agents, representatives, or any other person or persons acting on your behalf, and not merely such information as is known by you on personal knowledge.
- B. If you cannot answer any of the following Interrogatories in full, after exercising due diligence to secure the information to do so, so state, and answer to the extent possible, specifying your inability to answer the remainder, and stating whatever information or knowledge you have concerning the unanswered portions.
- C. Each Interrogatory is intended to and does request that each and every, all and singular, the particulars and parts thereof, be answered with the same force and effect as if each part and particular were the subject of and were asked by a separate Interrogatory.
- D. If any of the documents requested have been lost, misplaced or for any reason now not attainable, furnish a list identifying:

- (1) each such document,
- (2) the author and addressee,
